



Beyond Good Purchase Raffle

Promotion Description:

The Beyond Good Purchase Raffle (“Beyond Raffle”) is administered by the Lemur Conservation Foundation (“LCF”). The Beyond Raffle will grant one lucky winner a prize from Beyond Good. Beyond Raffle tickets will be earned by making an online purchase of Beyond Good products using the [LCF gift shop link](#) from October 17, 2021 to October 28, 2021, after which the winner will be randomly selected on October 29, 2021 and notified via email. Please note, a purchase is necessary to enter the Beyond Raffle.

Eligibility:

To enter the Beyond Raffle, a person must complete an online purchase from Beyond Good using the [LCF gift shop link](#) by October 28, 2021. Only participants with a verified purchase may be entered into the Beyond Raffle. Participants will receive one raffle entry per purchase per day.

Raffle entry can be earned in two different ways. Visit www.bit.ly/LCFESCAPE21 and complete the 2021 Digital Escape Room to enter an additional raffle (World Lemur Festival Raffle), no fee or purchase necessary.

Official Prize:

Winner Selection:

The Beyond Raffle will end on October 28, 2021 and one winner will be announced on October 29, 2021. The winner will be chosen in a random drawing and will be notified by email.

Potential winners are subject to verification by LCF, whose decisions are final and binding in all matters related to the Beyond Raffle. LCF will not accept photographs or other evidence of participation in lieu of a verified purchase from Beyond Good using the LCF gift shop link. If a potential winner of the prize cannot be contacted, or prize is returned as undeliverable, such potential winner forfeits the prize. In the event the prize winner is disqualified for any reason, LCF will award the prize to an alternate winner by random drawing among all remaining eligible entries.
